- Fair Districts PA supports PA Senate Bill 22, a bipartisan proposal introduced by Senators Lisa Boscola, a Democrat, and Mario Scavello, a Republican, in February 2017. Fair Districts PA also supports PA House Bill 722, a bipartisan proposal introduced by Representative Eric Roe, a Republican, and Representative Steve Samuelson, a Democrat, in April 2017.
- Both SB 22 and HB 722 propose to create an independent citizens commission in charge of both legislative and congressional redistricting.
